

National News from OPEN

Join the **Oral Health Progress and Equity Network (OPEN**) for our 2023 Virtual Hill Day on September 12-13, 2023. The OPEN Virtual Hill Day is a powerful advocacy tool to present a clear, unified voice to Members of Congress about the importance of oral health to their constituents.

As we approach OPEN's virtual Hill Day on September 12 & 13, we wanted to share OPEN's three primary policy asks. This fall, we will urge Congress to support:

- The Heads Up Act which authorizes HHS to award grants to support health centers that provide services for individuals with developmental disabilities, including dental care.
- Increased access to oral health care for veterans
- Parity among federal oral health funding for all states, such as CDC & HRSA grants

These "asks" have the most traction in Congress right now, and we believe they will set up OPEN members for a successful Hill Day. We will be working on materials such as policy one-pagers and talking points to prepare Hill Day participants for their virtual meetings with legislators. We will also include brief talking points on Medicaid and Medicare for Member Offices that are interested.

September 12th from 1:00 - 5:00pm ET: On day one, participants will gather for a kick-off call to learn about our 'asks' or policy priorities and to create a game plan with the participants from their state to ensure successful meetings with Members of Congress.

September 13th schedule varies depending on Member

appointments: On day two, virtual meetings with your Members of Congress and/or their staff will take place.

How it works

- 1. You register for the event.
- 2. OPEN schedules virtual appointments with your Members' offices, trains you on how to conduct a successful meeting, and provides you with all meeting materials.
- 3. You attend virtual appointments with participants from your state to educate Members and their staff on the importance of oral health to overall health!

Who can participate in Hill Visits with Members of Congress?

Almost anyone can serve as an advocate for improving oral health by engaging their Members of Congress. All private citizens and most 501c3 employees are able to advocate and to lobby. However, if you are employed by the Federal government or by state government, you may be prohibited from participating in any activity that could be perceived as "lobbying." That said, there may be some opportunities for you to educate your Member on the state of oral health in your community/state without discussing specific policies. If you are not sure about what you are allowed to do, check with your employer.

If I can't participate in Hill Visits, can I still register for the event?

Yes! You can register to attend the Kick-off event on Sept. 12th from 1:00 -5:00pm ET which will feature a policy panel, remarks from oral health champions in Congress, and policy focused skill building workshops.

Silver Diamine Fluoride: A Game Changer in Dental Public Health

Silver-containing products have been used as antimicrobial agents for many years in many medical applications, including dentistry. Silver

diamine fluoride (SDF) has been used for caries management in other countries for more than 80 years and gained acceptance by the US Food and Drug Administration in 2014. This presentation will summarize the clinical evidence for SDF as a topical agent to arrest or prevent dental caries. It will discuss the mechanisms by which SDF works, its clinical indications, and recent research on the public health benefits of incorporating SDF into dental caries prevention and control.

After the webinar, participants will be able to:

- 1. Discuss the probable mechanisms through which silver diamine fluoride arrests dental caries.
- 2. Describe the indications for using silver diamine fluoride and its method of application.
- 3. Describe the limitations of silver diamine fluoride.
- 4. Describe the potential public health benefits of incorporating SDF into community-based programs to prevent and control dental caries.

Momentum for Medicaid Adult Dental Coverage

Six states implemented adult dental benefits for the first time or significantly strengthened their existing benefits between 2020 and 2022. This is just one key takeaway in the updated Medicaid Adult Dental Coverage Checker — an interactive tool for policymakers, administrators, and advocates. The Coverage Checker provides a snapshot of a state's Medicaid adult dental benefits package, looking at coverage of specific procedures and services in eight categories.

Disposable e-cigarette use rising among teenagers

"Disposable, flavored vapes are not supposed to be sold in the U.S. The Food and Drug Administration began cracking down on vaping in 2020, by requiring e-cigarettes get regulatory approval in order to sell. To date, the agency has <u>authorized only 23 specific e-cigarette products</u>, all of which are tobacco-flavored alternatives to cigarettes, targeted at adults"

Yet many young people are still finding ways to get illegal products, specifically the disposable and flavored vapes, from retailers and online sellers, with unapproved products seeing a major surge from 2020 to 2022.

The Texas Primary Care Office Primary Care Provider Survey

Hello Dental Healthcare Partner(s),

The Texas Primary Care Office (TPCO) has been tasked with updating Texas primary care provider data (Primary Care, Mental and Dental) by the Health Resources and Services Administration (HRSA) Bureau of Health Workforce (BHW) Division of Policy and Shortage.

The federal Shortage Designation Branch requires specific data to be submitted in applications requesting designation of an area or population group as a Health Professional Shortage Area (HPSA) or Medically Underserved Area/ Population (MUA/ P). The required information consists largely of primary care providers names, specialties, office locations, hours per week in direct patient care activities, information on the provider's patient population, and information on other activities the provider might be engaged in outside of patient care.

HPSA designation is among the criteria tools that many programs use to increase the supply, capacity, and distribution of health professionals in areas that have a verifiable shortage of providers.

In reviewing the designation status of areas within Texas, the Texas Department of State Health Services collects data primarily through surveys of provider offices and a combination of supplemental data sources such as online resources and available data sets. The document linked below is the current version of the survey/assessment used to collect shortage designation data. Reviewing this survey should assist in familiarizing you with the information required for evaluating shortage designations. Interested providers and offices may also feel free to proactively complete surveys/ assessments and return them to the Texas Primary Care Office.

 For dental health: Include Dentists and considers the number of Dental Auxiliaries. Dental auxiliaries are defined as any non-dentist staff employed by the dentist to assist in the operation of the practice. Please note that providers solely engaged in administration, faculty, research, training, and inpatient care should be identified as they are excluded from the population -to provider ratios.

If an organization has more than 10 providers, TPCO may assist by providing an Excel spreadsheet which would allow the provider list/data to be compiled in one document and quickly uploaded.
