TMHP Telehealth Benefit Updates for Texas Medicaid Effective November 1, 2023

The Texas Medicaid & Healthcare Partnership (TMHP) recently published new Telehealth Benefit Updates. These changes include the implementation of a new

telehealth patient site facility fee benefit for federally qualified health center (FQHC) and rural health clinic (RHC) providers and clarification of current guidelines.


Note: Telehealth includes teledentistry services.



TxOHC Monthly Webinar | Register here | October 13, 2023 | 12:00 PM CDT The Healthy Smiles Project: Increasing HPV Vaccination through Interprofessional Partnerships with Dental Hygienists

Presented by: Stacey Griner, PhD, MPH, RDH

The presentation focuses on the role that oral health providers, such as dental hygienists, may have as alternative providers of HPV vaccine recommendations. We discuss their ability to reduce missed HPV vaccine opportunities and present information about HPV vaccine uptake and oral health providers in Texas. We then discuss an ongoing project with two goals: 1) to educate dental hygienists about advocating for the HPV vaccine, and 2) increase HPV vaccine implementation into the dental setting through community-based immunization events.

The guide features materials on data and surveillance; policy; professional education, tools, and training; program development; and public education. Selected materials include a toolkit to help improve the quality of school meals, best practice reports about school-based dental sealant programs and about use of fluoride in schools, and a curriculum for students in kindergarten through grades 10.
